Whilst the petrol Golf has a lower monthly rental, the all-electric ID.3 is actually cheaper over the lifetime of the contract by more than £3,300.

Multiplied across a typical 50 vehicle fleet, the vehicle with the higher monthly rental would actually save more than £165,000 over the duration of the contract.
